- Group 1 is not permitted to sublet or charge fees to outside groups for use of Board Property
- School events always take precedence over outside use of any district facility or property
- Group I users may be charged a Utility Fee if applicable
- Rental fees must be paid two (2) weeks prior to the scheduled event
- Custodial Fees are based on actual hours worked by assigned personnel
- Police and/or Fire Personnel may be required for facility use and are not included in this fee schedule
- The Superintendent has the authority to negotiate rates that are beyond single use events

\* Custodial rates are costs based on available staffing/date/time of event

\*\* Kitchen Worker: subject to Food Service Company's review

\*\*\* Requires permission from Food Service Company to use kitchen

\*\*\*\* Custodial Fee for field use may be waived with approval of Superintendent
